In the spirit of Christmas and the upcoming 2012, we would like to thank you for working with us to address the development challenges in Asia and the Pacific.

By the end of 2011, ANZDEC would have completed 7 projects –

Bangladesh: ADB Second Chittagong Hill Tracts Rural Development Project, May 2010 – Oct. 2011. PPTA to prepare a sector development project for improved rural livelihoods to reduce poverty amongst rural population of Chittagong Hill Tracts.

Lao PDR: ADB Building Capacity for the Health Sector Program Approach, June 2010 – May 2011. CDTA to develop the program planning and funding mechanism, and improve financial management for the health sector program approach at the provincial and district levels.

India: ADB Integrated Water Resources Management & Sustainable Water Service Delivery in Karnataka, June 2010 – Dec. 2011. CDTA to help the State Government of Karnataka define and adopt an appropriate system of water resources management following integrated water resources management principles.

Nepal: ADB Decentralized Rural Infrastructure and Livelihood Project II, Dec. 2010 – May 2011. PPTA to address the due diligence requirements for a project or sector project or supplementary financing modality and support investment preparation for core sub-projects to be financed, including nine district roads construction / rehabilitation sub-projects that could not be financed from DRILP and trail bridge and strategic community complementary access sub-projects.

Cook Islands: NZAID Cook Islands Marine Resources Institutional Strengthening Project, Dec. 2005 – March 2011. Capacity building for the Ministry of Marine Resources (MMR) and related agencies to enhance the management and sustainable use of marine resources for the benefit of all Cook Islanders.

Philippines: Government of the Philippines/ADB Health Sector Development Project – Project Implementation Consultants, June 2009 – May 2011. Assisted GOP to implement the HSDP which is an umbrella program of the Health Sector Reform Agenda.

Pakistan: Government of Pakistan/ADB Agribusiness Development Project, April 2006 – June 2011. Project implementation support to develop a more competitive and sustainable agribusiness subsector in Pakistan.

In 2011, we won 3 new contracts –

Pacific Regional: ADB Strengthening Coastal and Marine Resources Management in the Coral Triangle of the Pacific (Phase 2), Nov. 2011 – Nov. 2015. ANZDEC is the Program Management Consultant (PMC) for this regional policy and advisory technical assistance to implement a four-year program to strengthen the management of coastal and marine resources in 5 Pacific Coral Triangle countries. It will assist Papua New Guinea, Solomon Islands and Timor Leste in fulfilling their Coral Triangle Initiative objectives and engage Fiji and Vanuatu in such activities.

Asia and the Pacific: ADB Enabling Climate Change Response in Asia and the Pacific – Capacity Development to Address Climate Change (Subproject 3), Sept. 2011 – Dec. 2012. The TA will strengthen the capacity of participating DMCs in Asia and the Pacific and development practitioners to apply the best available climate change knowledge to development planning.

Solomon Islands: NZAID Public Finance Management in Education Sector, Sept. 2011-Nov. 2012. The purpose of this assignment is to establish and embed good public financial management practices in the education sector. The goal is improved quality of expenditure by Solomon Islanders of Solomon Island Government and sector budget support
